Many Americans are not aware that medicines which languish in home cabinets are highly susceptible to diversion, misuse, and abuse. Rates of prescription drug abuse in the U.S. are at alarming rates, as are the number of accidental poisonings and overdoses due to these drugs. Studies show that many abused prescription drugs are obtained from family and friends, including from the home medicine cabinet. In addition, many Americans do not know how to properly dispose of their unused prescription medicine, often flushing them down the toilet or throwing them away – both potential safety and health hazards.

Beginning in 2017, the District Attorney placed 19 Prescription Drug Take Back Boxes in cooperating police departments to encourage citizens to safely dispose of unused or expired medications.

All dry medications are accepted. They may be deposited in their bottles or punch cards. Labels do not need to be removed. No liquids or needles, please!

At least once every quarter the Beaver County Detective Bureau empties the boxes in the presence of an officer from the sponsoring police department. The drugs are weighed and removed to the Detective Bureau Evidence Room. All collected medications are incinerated under the observation of federal agents from the DEA and/or the National Guard. The chain of custody is carefully maintained to insure that all medications which are collected are tracked and incinerated. The medications remain sealed so the identity of individuals and medications remain confidential.

As of October 2018 the Beaver County Prescription Drug Take Back Box Program has collected and destroyed over 4400 pounds of medications. That's over 2 tons. That's lots and lots of pills!
