I understand that this release discharges Conway Borough from any liability or claim that I, my heirs, or any personal representatives may have against the Borough with respect to any bodily injury, illness, death, medical treatment, or property damage that may arise from, or in connection to, any activity at Conway Borough. This liability waiver and release extends to the pool together with Conway Borough, its Elected and Appointed Officials and Employees.

- Key for the water must be picked up at the Borough Office on the Friday before the reservation no later than 4 PM. Failure to do so will result in loss of use of water.
- **Motor vehicles are not permitted on the grass or paved surfaces of the park.** Driving down to the pavilion is prohibited. Parking is to be on the street.
- Park rules must be observed. Park is still open to the general public.
- Any person(s) reserving the Park assumes the risk of and waives any and all claims it may have against the Borough with respect to any and all damage to property or injury to persons that occur during the use of the Park, either through the use of Borough amenities, or through the use of any items brought to the Park.
- By signing this agreement, the person(s) renting the Park agrees to indemnify and hold harmless the Borough of Conway, its Elected and Appointed Officials and Employees, from any and all liabilities, losses, costs, damages, expenses (including attorney's fees and other costs of litigation), claims demand and judgements, in law or equity, which arise from or relate in any way to the use of the Park for the reserved period. This applies to any claims which may be brought by third parties as well as by the person reserving the park and/or any of his/her/its guests, invitees, outside vendors, visitors or members (or any of their respective heirs, administrators, executors, agents or assignees).
